Does Greece have a battery storage pipeline?

Greece has emerged as one of the countries with the largest pipeline of battery storage projects, but as yet there has been little activity on the ground. This is changing as the long-awaited storage subsidy auctions have started, with the first projects being awarded support for both investment and operating costs.

Can a battery storage plant be built in Greece?

An increasing number of local and foreign companies are interested in building energy storage facilities in sun-loving Greece using battery technology. In fact, the Regulatory Authority for Energy (RAE) has been receiving applications for permitsconcerning battery storage plants.

Which companies have a 400 MW battery capacity?

Other companies include Magna Victoria, Melven, Mars BESS and MS Komotini, which have already received permits for a combined 400 MW of battery capacity in various large projects. MS Komotini is one of seven subsidiaries of Motor Oil that have submitted applications for over 300 MW of storage.

Currently there is a growing interest for investments in storage facilities in Greece. Licensed projects mostly consist of Li-ion battery energy storage systems (BESS), either stand-alone or integrated in PVs, as well as PHS facilities [1].

The first call for projects was for those between 200kW to 2MW in size, either renewable generation or energy storage. Some 200 projects won a total of BGN107 million (US\$60 million) in that call, adding up to 435MW of renewables and 176MW of energy storage. The second call was for those over 200kW with no upper limit.

Before the end of 2024, Greece intends to provide subsidies for standalone battery projects of 200 MW in total via the third auction. The Ministry of Environment and Energy issued a decree determining the available operating power quota. Together with the support awarded in the first two auctions, the volume would reach 900 MW, just short of the 1,000 MW ...

The quota for battery units is 200 MW in total operating power and an energy storage duration of four hours, providing a total of 800 MWh to the system, the document reads. The facilities will be installed in the Western Macedonia region in northern Greece and in the municipalities of Megalopolis, Tripoli, Gortynia and Oichalia in the ...

The pipeline of prospective battery storage projects now approaches 27GW, with over 500 projects granted a storage license. With support for 1GW of battery capacity to be auctioned 3 tranches this year, the ...

The auction seeks to award 200 MW of battery storage projects, 100 MW less than initially announced when the 1 GW subsidy program for this type of energy storage was announced. The four-hour storage systems ...
