When did Aggreko acquire Poit Energia?

Aggreko acquired all the activities, other than those relating to large gas turbines, of General Electric Energy Rentals for around \$212m in December 2006. In March 2012, Aggreko acquired 100% of the operations of Poit Energia, a supplier of power generation equipment in Latin America.
