What are the health and social security issues in Andorra?

Healthcare and social security issues in Andorra are based on a simplified and centralized system that is very efficient. In this case, only one organization is in charge of regulating all the social and health insurance schemes in the country: CASS, Andorran Social Security Fund (Caixa Andorrana de Seguretat Social).

Is Social Security compulsory in Andorra?

Membership in the Social Security Fund (CASS) is compulsoryin Andorra for all employees who exercise a professional activity and for the vast majority of residents. The social security and health insurance scheme in Andorra is divided into two distinct branches:

What is Cass & how does it work in Andorra?

The CASS, social security of Andorra, is the body responsible for collecting contributions and ensuring social reimbursements: sickness, old age, disability, death, etc. Let ´ s focus on its functionality. First thing to know: you can move to Andorra and go to the Principality without any hassle.

What is the competitiveness of the Andorran social security system?

The competitiveness of the Andorran social security system is based on the effectiveness of the CASS Andorra(Caixa Andorrana de Seguretat Social), a state body in charge of the management of health insurance and old-age insurance.

How is the Andorran social security system centralized?

The andorran Social Security system it is centralized in a single public institution, in charge of the administrative, financial and technical management of the entire system: the Andorran Social Security Fund, also designated with the initials CASS.

When was Social Security established in Andorra?

It was established in April 1968. Since the Constitution of Andorra was approved in 1993, the objective of the Andorran system is to implement Article 30: « The right to health protection and to receive benefits to meet other personal needs is recognized. To these ends, the State will guarantee a Social Security system &#187:.
