Should Belgium remove fossil fuels from its energy mix?

Whilst Belgium is now able to meet over 20% of its electricity needs through wind and solar, removing fossil fuels from the mix would make the country vulnerable to periods of reduced renewable production.

What is Belgium's energy supply?

In 2020, fossil fuels (mainly oil and natural gas) accounted for 71% of its energy supply. Most fossil fuel demand comes from industry and transport, but Belgium's buildings also have a notable demand for gas, while oil covered 33% of residential building demand in 2020.

Why do we need a green energy supplier in Belgium?

As a result of the energy transition, to us it is important that the energy we consume is generated in a green way in Belgium.
