The final sale is still subject to a number of other conditions but will most likely take place on a date to be determined in early 2023.

The Rijnmond power station in Rotterdam Pernis has been acquired from Blackstone and the Sloe power station in the province of Zeeland has been acquired for 50% from EDF S.A. and 50% as part of PZEM.
