### How can the Cayman Islands build climate resilience?

With a target of 70 percent renewable energy by 2037,the Cayman Islands is seeking to build climate resilience by purchasing clean energy for its electricity supply. The country established its first utility-scale solar project in 2017 through a power purchase agreement with renewable energy generated from the Bodden Town Solar Farm.

### Can a non-citizen work in the Cayman Islands?

To work in the Cayman Islands as a non-citizen, a work permit is required. This involves passing a police background check and a health check. A prospective immigrant worker will not be granted a permit unless certain medical conditions are met, including testing negative for syphilis and HIV. A permit may be granted to individuals on special work.

How many shipwrecks are there in Cayman Brac?

There are two shipwrecksoff the shores of Cayman Brac, including the MV Captain Keith Tibbetts; Grand Cayman also has several shipwrecks off its shores, including one deliberate one. On 30 September 1994, the USS Kittiwake was decommissioned and struck from the Naval Vessel Register.

Why is the Cayman Islands a good place to live?

The Cayman Islands is considered to be part of the geographic Western Caribbean zone as well as the Greater Antilles. The territory is a major offshore financial centre for international businesses and the rich mainly due to the state charging no tax on income earned or stored.

How many vessels are there in the Cayman Islands?

As of 31 December 2015,360commercial vessels and 1,674 pleasure craft were registered in the Cayman Islands totalling 4.3 million GT. The Cayman Islands has a population of 69,656 (as of 2021) and therefore a limited workforce. Work permits may, therefore, be granted to foreigners.
