The U.S. has limited direct solar importsfrom China through policies such as the Uyghur Forced Labor Prevention Act and tariffs established to protect American industry from dumping and non-competitive practices. Yet, many solar modules assembled in Vietnam, Thailand, and Cambodia, the largest sources of U.S. solar panels, use Chinese components.

## Does China have a solar energy industry?

China unleashed the full might of its solar energy industrylast year. It installed more solar panels than the United States has in its history. It cut the wholesale price of panels it sells by nearly half. And its exports of fully assembled solar panels climbed 38 percent while its exports of key components almost doubled.

A flood of cheap Chinese solar panel imports is driving record solar energy installations. But those same imports are crushing Europe's few local solar manufacturers. Governments and industry are split over how to respond. Europe just had a bumper year for green energy.

Where are Chinese solar panels made?

The Chinese firms had set up factories in Southeast Asia, but Commerce Department officials said that some were not doing substantial manufacturing there. Rather, they were using sites in those countries to make minor changes to Chinese-made solar products, and then shipping them to the United States tariff-free, the ruling decided.

#### Can China make solar panels?

The company's U.S. projects could tap renewable energy manufacturing subsidies provided by President Biden's Inflation Reduction Act. China's cost advantage is formidable. A research unit of the European Commission calculated in a report in January that Chinese companies could make solar panels for 16 to 18.9 cents per watt of generating capacity.
