It is developing the associated Kidston Pumped Hydro storage using the abandoned Kidston Gold Mine. Genex Power also operates the Bouldercombe 50MW/100MWh battery, located near Rockhampton.

Who owns Genex?

Genex's largest shareholder Skip Capitalbacked the bid. Skip Capital, an investment firm founded by Atlassian co-founder Scott Farquhar, holds 19.9% of Genex, local media reported on Tuesday. How many shareholders backed Genex?

The bid was backed by 94.88% of shareholder votes cast in the Genex investor meeting, surpassing the requirement of at least 75% for the deal to proceed. A majority of individual shareholders backed the deal, the company added. The scheme is projected to become effective on July 31, once other regulatory approvals are received.
