What is the future of Bess in Latin America?

To provide a view of what is to come, AMI breaks down the status and opportunities of BESS in main Latin American markets. Chile passed an energy storage and electromobility bill in late 2022, making stand-alone storage projects profitable for operators.

What is the first solar-plus-storage project in the Dominican Republic?

Construction has started on the first major solar-plus-storage project in the Dominican Republic, which features a 24.8MW/99MWh battery energy storage system (BESS). The Comisión Nacional De Energia (CNE) of the Dominican Republic announced the start of work on the Dominicana Azul solar projectshortly in late December (22 December).

Does Peru have a Bess regulation?

Peru has no existing BESS regulationand is currently evaluating how to move forward with battery storage projects. In fact,in January 2024,Peru's energy and mining investment regulator,Osinergmin,opened a request for a proposal for a study on energy storage.

Will a PPA add Bess in Puerto Rico?

Under ASAP,IPPs with existing PPAs with Puerto Rico's Power Authority (PREPA) would add BESSat their locations "on an accelerated basis," leading to an estimated 380 MW of additional contracted BESS capacity by 2026. 3 Peru has no existing BESS regulation and is currently evaluating how to move forward with battery storage projects.
