How many GWh of electricity is produced in Portugal?

Between January 1st and May 31st of 2023,18,751 GWhof electricity were generated from Continental Portugal, from which 73.2% came from natural resources (sources (30.5% wind,28.30% hydro,7.6% bioenergy and 6.8% solar). Other sources include: Natural Gas (15.9%),Fossil CHP (4.7%),and Pumped Storage (6.2%).

Why is wind energy important in Portugal?

Wind energy remains a crucial component of Portugal's electricity production, accounting for 25% of the total. Meanwhile, the rapid expansion of hydroelectric and solar energy capacity is helping Portugal meet growing energy demands in a sustainable way.
