How did Energy Vault get funding?

In 2019, Energy Vault secured funding from Cemex before going on to secure \$110m of Series B funding to become the first energy storage investment of the SoftBank Vision Fund, and won Fast Company's World Changing Idea Award for transformative utility-scale energy storage.

Where is Energy Vault located?

Energy Vault's Rudong, China facility is under construction. The fabrication of an EVx facility is essentially a large-scale civilian engineering project and, other than Energy Vault's intellectual property, the vast majority of inputs required to build the facility are available from local suppliers.

Who owns Energy Vault holdings (GWHR)?

Upon closing of the transaction, the combined company will be named Energy Vault Holdings, Inc. and is expected to be listed on the NYSE under the ticker symbols "GWHR" and "GWHR WS," respectively. The combined company will be led by successful entrepreneur Robert Piconias Chairman and Chief Executive Officer.

Clear Market Need for Energy Vault: Demand for clean energy is growing globally, with renewables expected to become 90% of total energy generation by 2050, according to a recent IRENA report.
