How ENTSO-E & UkrEnergo are working together?

ENTSO-E and Ukrenergo have been working together since 2017 to achieve such integration. A notable milestone was reached on 16 March 2022 with the emergency synchronisation of Ukraine and Moldova with the Continental Europe power system.

Why did ENTSO-E complete synchronisation project with Ukraine?

In November 2023, ENTSO-E announced the successful completion of synchronisation project with Ukraine after the compliance by Ukrenergo with the key technical requirements necessary to enable a permanent interconnection between the power systems of Continental Europe and Ukraine.
