## What is safety and health at work in Italy?

In Italy,the institutional system of safety and health at work comes under the Ministry of Labour and Health,in conjunction with the Regional Coordination Committees and the social partners. Their responsibilities include delivering advice for legislative developments, supervision, promoting health and assisting businesses.

Who coordinates safety and health at work in Italy?

The Italian Focal Point is represented by Inail, which coordinates the national network of the European Agency for Safety and Health at Work. Do foreign workers need occupational health and safety training in Italy?

Occupational health and safety training in Italy (for foreign workers). All Employes operating in Italy must attend an occupational health and safety course. The lack of training of employes may involve criminal penalties for the employer (as is often the case for non-compliance of occupational health and safety in Italy).

Do you need a risk assessment training in Italy?

According to Italian law,risk assessment training must be given to their workers in all companies order not to risk sanctions. There are many compulsory training courses and all paid by the employer: from general to specific training,up to emergency management (which we analyse in a later chapter).

Who is a high risk worker in Italy?

Low risk (4 hours): street vendors, restaurateurs, artisans, tourist agents and merchants for example. Medium risk (8 hours): transporters, warehouse workers for example. High risk (12 hours): workers engaged in construction, chemistry and, in general, in the processing of hazardous substances. There are also other courses required by law in Italy.

The Consolidated Law on Safety at Work lists in detail the obligations that the Employer must fulfill to safeguard the safety of workers. It is based on well-defined principles such as: assess ...
