Why did Eswatini modify its energy policy?

Eswatini modified its energy policy due to a desire to improve energy security, access to reliable, adequate, and affordable electricity, and mitigate potential detrimental impacts on the environment because of the growing energy demand.

What is energy development in Eswatini?

The energy development in Eswatini is guided by the National Energy Policy of 2018. Since then, the country's energy sector has been undergoing rapid transformation with the liberalization of the electricity sector to encourage private sector investment.

What is Eswatini's energy revolution?

Eswatini's energy revolution is a testament to its dedication to sustainability and self-sufficiency. As Eswatini strides into the future with renewable energy,the convergence of local innovation,international collaboration and growth-oriented policies promises to illuminate every corner of the nation.

What is Eswatini's Energy Master Plan?

Eswatini has developed an Energy Master Plan that presents further possible scenarios for new power generation capacity up to 2034. The plan was supplemented with a five-year Short-Term Generation Expansion Plan (SGEP)prioritizing 40 MW solar and 40 MW biomass power generation plants.

What is Power Africa's involvement in Eswatini?

Does Eswatini have a mothballed generator?

Eswatini's EEC owns a mothballed 9 MW diesel generatordue to high operating costs. To enhance energy security and self-sufficiency,the Government of Eswatini is developing additional generation capacity to meet the country's energy demand.

The persistence of poverty in Eswatini, and particularly in rural areas, is exacerbated by poor macroeconomic conditions, high unemployment rates particularly among youth, and adverse weather conditions. Eswatini's livelihood is based on agriculture, and its economy is largely derived from agricultural export.

The minister was also captured by Eswatini TV recently stating that the ministry was doing a feasibility study at Ngwempisi Hydro Power Station, which has the potential to generate 200 megawatts of electricity. Generating "Eswatini will be generating its own power by 2025," he said when interviewed outside parliament last week Wednesday.

The vast majority of Eswatini's power supplies are imported from South Africa, which inhibits the country's potential to be economically independent and is less cost-effective overall. Plus, although Eswatini's electrification rates are relatively high, they are still a long way off 100% (the country's target for 2022). ...
