Why did Exide merge with svolt energy technology?

The second wholly-owned subsidiary was formed following an agreement in March 2022 for Exide to collaborate with China's SVOLT Energy Technology to manufacture lithium ion battery cells in India. Exide said the merger was appropriate given the similar lines of business of the subsidiaries.

Will Exide Leclanche merge with Exide Energy Solutions Limited?
