What is Fiji's energy policy?

This Policy will ensure that Fiji's agricultural sector and local industries can benefit from a further source of sustainable, indigenously-sourced energy while minimising any potential impacts on the environment or national food security.

Why does Fiji rely on fossil fuels?

National energy production and consumption in Fiji remains highly dependent on imported fossil fuels in part due to the current demands of the transport sectorand the ongoing reliance on thermal power plants to supplement renewable energy sources within Fiji's electricity sector.

How does Fiji generate electricity?

Today, as much as 60% of Fiji's electricity generation is derived from hydropowerwhile remote islands and some rural areas are largely dependent on energy production powered by imported fossil fuels. The growth of Fiji's land transport sector has been largely concentrated around growing urban centres.

How does Fiji ensure long-term energy security?

The Fijian Government seeks to ensure Fiji's long-term energy security by increasing the availability of data and information required to support investments designed to increase the reliability and resilience of the national energy infrastructure.
