Who owns Energy Fiji Limited (EFL)?

("Chugoku Electric") is pleased to announce that on March 25,2021,it has signed a share sale agreement for the acquisition of 44% stake in Energy Fiji Limited ("EFL") in Fiji via a special purpose company newly established in Singapore.

Is Fiji Electricity Authority a public company?

Fiji Electricity Authority (FEA) was corporatised into Energy Fiji Limited (EFL) on 16 April 2018,a public company limited by shares, and was registered under the Companies Act. EFL has also been appointed as the successor entity of FEA.

Does Fiji still own EFL & Chugoku Electric?

The Government of Fiji will retain ownership of a 51% equity stake of EFL and aims to promote renewable energy usage up to 100% in the country by 2036. Chugoku Electric intends to accelerate renewable energy development such as hydro power and solar power in the country together with EFL.

Does fiji16 need geothermal power?

Fiji16 is one of that, which can meet the energy needs by geothermal generation. In context of this, World Bank has also agreed to provide technical assistance to identify 2-3 major sites for geothermal-based power generation in Fiji (IRENA, 2015).

Where can geothermal power be generated in Fiji?
