Will EV tariffs increase in 2024?

Tariffs for EV battery cells will increase to 25% in 2024, with energy storage tariffs following suit in 2026, with the goal of leveling the playing field for US manufacturers that have long been undercut by cheaper imports. A notable pivot in policy is the imminent removal of the bifacial module exclusion under Section 201.

Will the US enforce a 180-day installation requirement for duty-free imported panels?

Concurrently, the administration has announced it will crack down on stockpiling practices by enforcing a 180-day installation requirement for duty-free imported panels. US Customs and Border Protection (CBP) will rigorously monitor compliance, necessitating detailed certifications from importers.
