Will new tariffs be imposed on solar panels from Southeast Asia?

The rumors were true: A new petition has been filed to the U.S. International Trade Commission (USITC) and the U.S. Department of Commerce (DOC), to apply new tariffs (both anti-dumping and countervailing duties) to imported solar cells and modules from Southeast Asia. As expected, the reaction from the U.S. solar industry depends on the source.

Are solar imports being unfairly sold in the US?

(Yen Duong/Bloomberg) (Bloomberg) -- Solar imports from Southeast Asia are being unfairly soldbelow their cost of production in the US, according to the initial findings of a Commerce Department review that laid out duties of as much as 271% to counteract the practice.

Are solar imports from Southeast Asia unfairly benefiting from government aid?

Those nations provide the bulk of US solar cell and module imports. The announcement comes nearly two months after the US agency issued preliminary findings from a separate but related probe that the solar imports from Southeast Asia are unfairly benefiting from government aid.

Will bifacial solar panels be removed from safeguard tariffs?

A notable pivot in policy is the imminent removal of the bifacial module exclusion under Section 201. Bifacial solar panels, which are predominantly used in utility-scale projects, have enjoyed an exclusion from safeguard tariffs.

What are solar panel import tariffs?

Solar panel import tariffs are primarily intended to support the development of a new U.S.-based solar module manufacturing supply chain, which is financially backed by the Inflation Reduction Act. This act introduces a series of tax credits designed to bolster domestic manufacturers. For solar modules, the credits are as follows:

Are solar suppliers being investigated in Southeast Asia?

A petition signed by the American Alliance for Solar Manufacturing Trade Committee coalition was filed in late April 2024 and, on May 15,2024, the US International Trade Commission and the Department of Customs announced an investigation would be launched into suppliers from the four Southeast Asian nations.
