How much does solar PV cost in France?

The average price for the previous tender was slightly higher with EUR102.1/MWh. Aside from the rooftop solar PV auctions, France also held a ground-mounted tender in March of this year, which awarded nearly 1GW of PV capacity.

Are France's solar PV auctions dwindling?

Aside from the rooftop solar PV auctions, France also held a ground-mounted tender in March of this year, which awarded nearly 1GW of PV capacity. After awarding over 500MW of capacity in the fifth tender, held in August 2023, the numbers have dwindledin the following auctions, as shown in the chart below.

How much does a power plant cost in France?

The French government has selected 329 projects in its latest procurement exercise. Average prices were EUR77.62/MWhfor large power plants (500 kWp to 8 MWp) and EUR87.23/MWh for projects below 500 kWp. From pv magazine France

What are the biggest energy projects in France?

The two largest selected projects, in terms of capacity, are a 42.8-MW scheme in Grant Est and a 40.1-MW project in Nouvelle-Aquitaine. Dhamma Energy, Technique Solaire and Engie are among the winning developers. France-based Neoen has bagged a total of 130.3 MWp. (EUR 1.0 = USD 1.133)

How much does a MWh project cost in France?

The French Ministry of Ecological Transition last week announced 38 winners in the second call. The average price of the proposals stood at EUR 68.51(USD 69.95) per MWh,up from EUR 58.84/MWh recorded in the initial tender,in which 71 projects were awarded.

How many power plants are there in France?

The authorities selected 292 projects in the category for installations between 100 kW and 500 kW in size. Technique Solaire won 84 projects, followed by Apex with 65 and Arkolia with 20. Geographically, Nouvelle Aquitaine will host 123 power plants, followed by Occitanie with 59 and Auvergne-Rhône-Alpes with 40.
