Does solar cost a lot in Georgia?

Solar is a major purchase, but you can get the price tag to come down a bit by being an educated shopper. Georgia doesn't offer any state-specific battery incentives. However, all batteries larger than 3 kWh are eligible for the same 30% federal tax credit as solar panels. Batteries can make good financial sense as part of a home solar system in Georgia.

How much does a 5 kW solar panel cost in Georgia?

In Georgia, the average cost for a 5 kW solar panel system is around \$13,160. Once you factor in the 30% credit, the cost of a solar panel system in Georgia comes down to \$9,212. When you file your taxes, you can claim this incentive as a credit towards your federal tax bill.
