How much does a solar PV grant cost in Ireland?

In Ireland, the solar PV grant amount is calculated based on the peak generation capacity of your solar panels, which is in kW or kWp. The grant amount is EUR900 per kWp for the first 2kWp, and EUR300 for every additional kWp up to 4kWp. The total grant is EUR2400 for installations of 4kWp or above.

What is a solar PV grant scheme?
