Who owns greencells Group Holdings?

To keep up with the strong market growth, Hoffmann and Kisauer founded Greencells Group Holdings, based in Abu Dhabi, with investor group Zahid in 2018. Greencells plans, finances and builds solar parks all over the world.

What happened to greencells?

That was the beginning of the company Greencells GmbH, which he founded together with Marius Kisauer in 2009. Initially, Greencells only installed solar modules. In 2012, there was a crash and consolidation of the German solar market, which Greencells survived and grew against the market trend.

What is a cell company in Jersey?

In Jersey, a cell company can be a protected cell company or an incorporated cell company. Cell companies can be public or private, limited or unlimited, and issue par value shares for one cell only. Investors have the option to set up a company in Jersey with a limited duration or life.

What does greencells do?

The Greencells Group is active in more than 25 countries and now employs more than 300 people. The 151 solar plants installed generate a total output of 2.4 gigawatts. To be able to guarantee the basic power supply with renewables, the company builds so-called hybrid power plants that combine solar energy with wind turbines and storage systems.

Why did greencells survive?

In 2012, there was a crash and consolidation of the German solar market, which Greencells survived and grew against the market trend. The reason for this was the expansion of its business areas. For example, Greencells entered project development and focused on building large-scale solar plants abroad.

Greencells GmbH Group posts strong full-year 2022 results with a 42% increase in consolidated revenue to EUR158.9 million in 2022 and significant increase in consolidated EBIT from EUR0.2 million to EUR7.9 million. Revenue growth to over EUR200 million planned in 2023.

With over 3.0 GWp installed capacity, Greencells Group is one of the biggest providers of utility-scale solar plants. Our portfolio spans Development, EPC and O& M services, guaranteeing an expert turnaround of our clients' projects.
