When did the sanctions regime start in Guatemala?

The sanctions regime in respect of Guatemala was established on 12 January 2024,to hold accountable those obstructing a democratic transition following the 2023 general elections, which resulted in a clear victory of President Bernardo Aré valo, as attested by the EU Election Observation Mission (EOM) to Guatemala.
