The Health and Safety at Work (General) (Guernsey) Ordinance 1987, places duties on employers to demonstrate that they have done everything reasonably practicable to ensure the Health, Safety and Welfare at work of their employees. Do you need health and Safety Insurance in Guernsey?

What legislation does HSE Guernsey use?

If there is no specific Guernsey legislation applicable, HSE Guernsey will use UK legislation, approved codes of practice and guidance as the appropriate standard to benchmark health and safety compliance. An ACoP has a special legal status.

Who should seek legal advice in Guernsey?
