Which energy companies are negotiating a production sharing deal with Guyana?

GEORGETOWN, Oct 16 (Reuters) - Energy firms TotalEnergies (TTEF.PA), Qatar Energy, Petronas (PETRA.UL), Cybele Energy, Delcorp and International Group Investment have reached agreements with Guyana over terms of production sharing deals to explore five oil and gas offshore blocks, the energy ministry said on Wednesday.

Is total a good investment in the Guyana Basin?

"Total is very pleasedwith this significant entry in the prolific Guyana Basin," says Arnaud Breuillac, President, Exploration & Production at Total. "The Canje, Kanuku and Orinduik blocks are located in a very favorable petroleum context, evidenced by the Liza discovery in 2015.

Are final documents pending for Guyana's energy projects?

Final documents for the areas have not been signed. Guyana's energy ministry also said in the release that a response from local energy company Sispro is pending related to its offers for two of the blocks.

How has Guyana's oil market changed over the past three years?

"Year-to-date, Guyana's oil exports have jumped to 598 thousand barrels per day (kbpd), a 58% year-on-year increase, adding to the growth achieved in previous years. Over the past three years, the average annual growth rate has hit 76%, "he noted. Guyana's oil boom began with ExxonMobil's ventures in the Liza field in the Starbroek Block.

Is Guyana a new player in global oil supply chains?

These FPSOs have made Guyana a significant new playerin global oil supply chains. According to BIMCO, Guyana currently accounts for just 1.3% of global crude tanker volumes, primarily soaking up both Suezmax and VLCC tonnage, but its impact on the market is growing.
