Are Chinese solar panels skirting US tariff laws?

Will a retroactive tax on solar panels hurt the solar industry?

Retroactive taxes on solar panels from China are likely to dramatically increase costs for U.S. solar installers. If the government decides to impose these taxes on the country's primary sources of solar panels, the resulting stress on the supply chain could put a damper on the solar industry's expansion.

What happened to solar panels after Biden paused tariffs?

In the two years since the Biden administration made the decision to pause the tariffs, solar prices have cratered, and solar panel imports have surged.

Which countries import the most solar panels?

Those countries -- Vietnam, Malaysia, Thailand, and Cambodia-- are responsible for nearly three-quarters of solar modules imported to the United States.

Are Chinese solar products undercuting the US?

The tariffs, which will apply to certain solar products made by Chinese companies in Southeast Asia, kicked in at a moment of growing global concern about a surge of cheap Chinese solar products that are undercutting U.S. and European manufacturers.
