## Is Northland Power acquiring Helia Renovables in Spain?

Canadian power company Northland Power has signed a definitive agreement with Helia Renovables to acquire a 540MWwind and solar portfolio in Spain. The wind power market has grown at a CAGR of 14% between 2010 and 2021 to reach 830 GW by end of 2021.

How much debt does Helia Renovables have?

The EUR345m (\$413m) deal includes the assumption of EUR716m (\$857m)of debt. Helia Renovables is a fund sponsored by Plenium Partners Asset Management and Bankinter. The portfolio consists of 33 operating assets with a combined onshore wind capacity of 424MW, a combined solar photovoltaic capacity of 66MW and a concentrated solar capacity of 50MW.

Why did Helia sell the asset portfolio?
