How does a solar PV rebate work?

For example, if your solar PV system was installed in 2022, installation costs totaled \$18,000, and your state government gave you a one-time rebate of \$1,000 for installing the system, your federal tax credit would be calculated as follows: $\$18,000 * 0.30 = \$5,400$

How much can you save with the federal solar tax credit?

How much do solar panels cost?

According to our 2023 survey of homeowners with solar, respondents paid an average of \$15,000 to \$20,000 for their solar panel systems. When you factor in the 30% federal solar tax credit, the average cost drops to a range of \$10,500 to \$14,000.
