

How to issue export certificate for energy storage cabinet

What is the Smart Export Guarantee (SEG) scheme?

The good news is that the Smart Export Guarantee (SEG) scheme introduced by the Department of Business, Energy and Industrial Strategy (BEIS) in January 2020, ensures small scale renewable energy generators get paid by electricity suppliers for the export of electricity back into the grid. Looking for your Import MPAN or electricity supplier?

Who should be contacted when importing or exporting electricity?

The regional Distribution Network Operators(DNOs) must be contacted when permission is required for certain higher-power devices which import or export electricity. These include PV Solar Panels,Home Battery Storage,Wind Turbines,Electric Vehicle chargers and Heat pumps. Export :

How do I get a Smart Export Guarantee?

Get in touch with your energy supplier to see if they offer this. The Smart Export Guarantee is a support mechanism that ensures people that generate their own electricity are paid for the electricity they export to the grid. This doesn't happen automatically, so you need to sign up to get the SEG tariff.

What happens if I export electricity from another SEG licensee?

You will then be responsible for seeking a new SEG tariff for your exported electricity from another SEG licensee. Any electricity exported between the point the contract from the previous SEG licensee stops and a new SEG contract is agreed with a new SEG licensee will not be the responsibility of the new SEG licensee.

What is a G100 energy export limit?

It will only allow a site to export what the Distribution Network Operators (DNOs) permit. G100 generally refers to the energy export limiting of the combination of inverters and power management equipment such as a smart meter- very rarely does an inverter (or series of inverters) get approved to export limit on its own.

What electricity export tariffs are required?

It requires licensed electricity suppliers to offer export tariffs to anaerobic digestion (AD),hydro,onshore wind,and solar photovoltaic (PV) generators with a total installed capacity up to 5MW,and micro-combined heat and power (micro-CHP) up to 50kW. The obligation came into force on 1 January 2020.
