

How to register a trademark for solar power generation

How do I Register my trademark?

You have the option to apply to register your trademark in either Trademark Center beta or the Trademark Electronic Application System (TEAS) until early January 2025. The cost to file remains the same in both systems. For more information, visit our Trademark Center page.

Does registering a trademark guarantee it will register?

Applying to register your trademark doesn't guarantee it will register. Therefore, you should do your best to make sure everything in your initial application meets the requirements for federal registration. Consider each of these items before you start your application. Your trademark application becomes public record once you submit it.

How do I apply for a trademark?

To apply,use the Trademark Electronic Application System(TEAS) to complete the initial application. The initial application form has two filing options: TEAS Plus and TEAS Standard. Costs differ between filing options because the filing options have a different number of up-front requirements. You must file electronically.

How do I use the trademark ID manual?

You can use the Trademark ID Manual to identify and classify what goods or services you're offering. The number of classes of goods or services you include in your application affects how much your application costs. Once you file your initial application, you cannot expand the scope of your goods or services. You can only narrow or delete them.

When does my trademark application become a public record?

Your trademark application becomes public record once you submit it. Except for payment information, all personal information you submit to us, including your address and email address, will become part of a public record viewable on our website and other websites that index USPTO data, such as Google. This is required by law.
