

## How to sell photovoltaic energy storage in Europe

How can the EU boost solar energy?

EU measures to boost solar energy include making the installation of solar panels on the rooftops of new buildings obligatory within a specific timeframe, streamlining permitting procedures for renewable energy projects, improving the skills base in the solar sector and boosting the EU's capacity to manufacture photovoltaic panels.

What is the European market for PV storage systems?

The European market for residential PV storage systems grew by 57 percent in 2019. The total newly installed capacity for storage systems was 745 megawatt hours.

Why is solar energy important in the EU?

Reducing the EU's dependence on fossil fuels, solar energy plays a key role in both the clean energy transition and the REPowerEU plan. Solar energy technologies convert sunlight into energy, either as electricity (photovoltaics and concentrated solar power) or in the form of solar heat. Why is solar energy so popular in Europe?

Solar energy is cheap, clean and flexible. The cost of solar power decreased by 82% between 2010-2020, making it the most competitive source of electricity in many parts of the EU. The EU solar generation capacity keeps increasing and reached, according to Solar Power Europe, an estimated 259.99 GW in 2023.
