How do I register a company in the Isle of Man?

Once your chosen name has been approved, you will need to complete the following documents and send them to the Companies Registry with the appropriate fee payable. Provides full particulars of the companies first directors and secretary and the intended address of the companies first registered office, which must be situated in the Isle of Man.

Are there any company laws in the Isle of Man?

The Isle of Man has two separate but co-existing company law regimes: The Companies Acts 1931-2004 (collectively referred to as the 1931 Act) and the Companies Act 2006 (the 2006 Act). We refer to all such companies in this guide as Manx Companies.

How many directors can a company have in the Isle of Man?

Provides full particulars of the companies first directors and secretary and the intended address of the companies first registered office, which must be situated in the Isle of Man. The company must have a minimum of two directors, one of whom may also be the company secretary. Corporate directors are not permitted under Manx Law.

Who governs the Isle of Man?

The Isle of Man is a self-governing crown dependency in the Irish Sea between England and Northern Ireland. The head of state is King Charles III, who holds the title of Lord of Mann. The Lord of Mann is represented by a lieutenant governor. Foreign relations and defence are the responsibility of the British Government.

A company that is incorporated elsewhere will be considered resident in the Isle of Man if it is "managed and controlled" in the Isle of Man, and it will be taxed on its worldwide income accordingly. "Managed and controlled" is generally interpreted as being the place where the board of directors meets, although this is not always conclusive.
