Who owns solar power?

The ultimate owner of the SRECs owns the "solar-ness" of the power. Many states create SREC markets to spur the development of solar by requiring electricity suppliers to purchase SRECs produced by in-state solar systems as part of their obligation under the state's Renewable Portfolio Standard (RPS).

Can a zoning ordinance prohibit solar energy?

Massachusetts law Chapter 40A states that "no zoning ordinance or by-law shall prohibit or unreasonably regulate the installation of solar energy systems or the building of structures that facilitate the collection of solar energy, except where necessary to protect the public health, safety or welfare."

Are there solar access laws in Minnesota?

There are no solar access laws in Minnesota, however, MN law 500.30 allows residents to create solar easements, and bills have been introduced and proposed to block HOA restrictions on solar energy statewide. There are no solar access or easement laws in Mississippi.
