AB KN Energies had revenue of 18.18M EUR in the quarter ending June 30, 2024, a decrease of -10.22%. This brings the company's revenue in the last twelve months to 83.74M, down -0.59% year-over-year. In the year 2023, AB KN Energies had annual revenue of 83.53M with 7.33% growth.

Lithuanian state company KN Energies will operate Germany's first set of four state-owned LNG terminals on the North Sea coast to smooth the country's transition away from reliance on Russian gas.

In addition, it stores and handles liquid energy products; and adds bio-additives and marks substances to oil products. The company was formerly known as AB Klaipėdos nafta and changed its name to AB KN Energies in January 2024. AB KN Energies was founded in 1857 and is based in Klaipėda, Lithuania.
