Are Malaysian solar companies set up in the US?

On the flip side, the US tariffs succeeded in nudging some of the solar players in Malaysia to set up in the US. For instance, Jinko Solar has been operating a growing US plant since 2021, while JA Solar and Longi have expressed plans to manufacture in the US as well.

How much does a Malaysian solar panel cost?

Channel checks show that China-manufactured panels sold in Malaysia were priced about 23 US cents per wattat the time of writing, compared to about 30 US cents for Malaysian-made panels sold in the US before tariffs. In other words, the Malaysian-made panel is about 30% more expensive than the China-made product.

Are US solar panels being harmed by cheap imports from Southeast Asia?

Washington moved closer to instituting the tariffs in June, with the US International Trade Commission passing an initial vote determining manufacturers are being harmed by cheap imports from Southeast Asia. US solar panel imports from Southeast Asia surged 36% to a record last quarter as buyers raced to lock in supply before tariff waivers ended.

Are Malaysian solar companies facing higher US duties?

Chong,the head of the Malaysian Photovoltaic Industry Association,said some affected solar companies were expected to gradually shift operations to countries facing lower US duties compared with Malaysia. Malaysian solar equipment shipped to the US will include a 9.13 per cent duty while two Malaysia-based foreign firms also face higher duties.

The US tariff hike on solar equipment exported from Southeast Asia to protect its domestic industry will likelydent demand for such products from Malaysia, according to an industry leader. The US Commerce Department on Wednesday announced increased duties on solar equipment exported by Cambodia, Malaysia, Thailand and Vietnam.

Will US tariffs affect Malaysian solar equipment?

Malaysian solar equipment shipped to the US will include a 9.13 per cent duty under the new tariff regime, albeit not as high as a 23.06 per cent rate for such exports from Thailand. Vietnam's solar exports face the lowest hike at 2.85 per cent, followed by an 8.25 per cent tariff for Cambodia.
