

What is Masdar doing in Riyadh?

Last year, Masdar opened a new office in Riyadh to manage projects that are part of the kingdom's plan to boost renewable energy capacity by 2030. Masdar aims to expand its capacity to at least 100 gigawatts of renewable energy by the end of the decade.

Who owns Masdar & Mubadala?

Masdar, owned by Abu Dhabi sovereign wealth fund Mubadala, did not disclose the value of either deal. Engie and Masdar formed a \$5 billion partnership in December to explore green hydrogen development in the UAE, aiming for at least 2 gigawatts of production capacity by 2030.
