## Microgrid incentive program Mauritius

What is the microgrid incentive program?

In January 2021, the Commission authorized the Microgrid Incentive Program, with a \$200 million budget, to fund clean energy microgrids to support the critical needs of vulnerable communities impacted by grid outages and to test new technologies or regulatory approaches to inform future action.

What did Commissioner Shiroma say about the microgrid incentive program?

Commissioner Genevieve Shiroma released an Amended Scoping Memo and Ruling for Track 4 Phase 2 and Track 5 of the Proceeding on December 17, 2021, including the Microgrid Incentive Program, a multi-property microgrid tariff, and the value of resiliency. Read it here.

How can Mauritius reduce its dependence on fossil fuels?

Through two different procurement exercises,the archipelago's Central Electricity Board seeks to reduce its dependence on fossil fuels. Mauritius had 83MW of installed solar generation capacity at the end of 2020.

Can staff facilitate the commercialization of microgrids under SB 1339?

Administrative Law Judge Colin (ALJ) Rizzo issued a ruling on July 23, 2020 requesting comment on staff's proposal for facilitating the commercialization of microgrids pursuant to SB 1339. Read it here. (Staff proposal and concept paper attached).

Who is the Commissioner for Microgrid resiliency?

Commissioner Genevieve Shiroma, the Assigned Commissioner for the rulemaking, released a Scoping Memo on December 20,2019. Read it here. The Commission voted to approve a decision for Track 1 of the proceeding on June 11,2020. The decision adopted short term actions to accelerate microgrid deployment and related resiliency solutions.

Does Mauritius have solar power?

The Indian Ocean island state has also been supporting distributed solar through net metering and rebates.
