The once-buzzy company had raised \$110 million in its four-year span, but now, per the filing, its checking account is down to \$201,980.

What is moxion power?

It is building high-powered, mobile energy storage technology that can be used pretty much anywhere.

Will moxion power shut down?

Startup Moxion Power, which makes a battery-powered generator, has furloughed most of its staff and could soon shut down, according to a report from SFGate. Why it matters: The chilly funding environment continues to catch up with capital-intensive climate tech startups seeking to scale. Moxion Power didn't respond to a request for comment.
