Should guidance on solar PV be included in the National Policy Statement?

The solar industry very much welcomes the addition of guidance on solar PV to the National Policy Statement for renewable energy infrastructure. However, there are several provisions which could be strengthened, which we have outlined below.

Do solar panels outlive warranty?

Yet, with solar panels' lifespans of around 25 years, they are likely to outlive the warranty. Manufacturing defects: Defects in manufacturing are typically covered by the manufacturer's warranty rather than solar panel insurance. Policyholders are encouraged to address manufacturing-related issues directly with the manufacturer or installer.

Do solar panels come with a warranty?

Solar panels typically come with a 25-year warrantycovering parts. However, they exclude damage from external factors like severe weather, where insurance plays a vital role. These warranties are known as solar equipment and solar performance warranties. Provides compensation, potentially free replacement panels.
