PAEG will be owned equally by BP and Bidas. Bidas is an independent oil and gas holding company. Since March 2010, it has been owned equally by the China National Offshore Oil Corporation and Bidas Energy Holdings.

PAEG will be owned equally by BP and Bidas Corporation, itself a 50:50 joint venture of Bidas Energy Holdings of Argentina and CNOOC Limited of China. PAE is currently owned 60 percent by BP and 40 percent by Bidas, while Axion is wholly-owned by Bidas. Completion of the agreement is anticipated in early 2018.

Bidas Corporation already holds the remaining 40% in PAE.
