Why did Nigeria start drilling for oil & gas?

ABUJA,Nov 22 (Reuters) - Nigeria's state-owned NNPC Ltd on Tuesday started drilling for oil and gas at a field in northern Nigeria that has reserves of 1 billion barrels,as the country seeks to produce crude outside the Niger Deltafor the first time.

How much oil does Nigeria produce a day?

In April, the country produced less than 1mn barrelsof oil daily, far below its 1.8mn bpd Opec quota. So, even though oil prices spiked in 2022, due to Russia's invasion of Ukraine, the longer-term story of Nigeria's energy industry has been one of lost opportunity.
