Solar PV EOL waste management regulations in different US states SB 489(2015): This law requires solar panel manufacturers to establish a program for collecting and recycling solar PV modules sold in California and report on their progress toward meeting recycling goals (Brokaw, 2015).

Are solar panels a hazardous waste under RCRA?

If these metals are present in high enough quantities in the solar panels, solar panel waste could be a hazardous waste under RCRA. Some solar panels are considered hazardous waste, and some are not, even within the same model and manufacturer.
