What is Bolivia's energy mix?

Bolivia's overall energy mix is dominated by fossil fuels, with natural gas (50%) and petroleum products (31%) supplying most of the country's energy in 2020. In 2021, Bolivia's national electricity agency ENDE announced its intention to generate up to 80% of the country's power from renewable sources by 2025.

What type of energy system does Bolivia use?

Similar to the country's total energy system, the power sector relies heavily on natural gas(AEtN,2016). The electricity network in Bolivia is broken into two classifications: the National Interconnected System (SIN) and the Isolated Systems (SAs).

Is there a long-term optimization model for the Bolivian energy sector?

To better answer this question, a long-term optimization model of the Bolivian energy sector was developed with OSeMOSYS, considering the national energy demands, disaggregated by fuel and type of consumer.

How will Bolivia's energy transition affect fuel imports?

Increase in CAPEX suggests that during the transition, fuel imports will reduce, particularly those for fossil oil. Using Bolivia's own excellent solar resources to generate synthetic fuels in BPS-1 and BPS-2 would result in energy independence and security.

Does Bolivia have a long-term energy plan?

As previously mentioned,the Bolivian government does not provide any long-term energy planning study,however,the UNFCC (2015b) states that RE will compose 81% of electricity generation by 2030. Bolivia's scenario for 2027 according to MHE (2009) states that biomass sources will comprise 8% of total final energy demand.

Primary energy consumption per capita is around 2.1 toe, including almost 1 100 kWh of electricity (2022). Graph: CONSUMPTION TRENDS BY ENERGY SOURCE (Mtoe) Total consumption has remained quite stable since 2014 at around 5 Mtoe (5 Mtoe in 2022), after a rapid increase between 2000 and 2010 (13%/year, i.e. a 3.5-fold rise).
