Who owns Pekat solar & MF solar Tronoh?

Pekat Solar, a wholly owned unit of Pekat Group, will undertake engineering, procurement, construction and commissioning (EPCC) works for the project, which was secured by MF Solar Tronoh under the Corporate Green Power Programme (CGPP). The project is expected to start in 4Q2024, with commercial operation date (COD) set at Dec 31, 2025.

Does Pekat have a large-scale solar project?

This is the second large-scale solar EPCC project award secured by Pekat this year. Recent solar-related projects won by Pekat include a power-purchase agreement in Maldives, estimated at US\$6.9 million, to provide electricity for 10 years from a 1.73MWp (megawatt peak) solar system, with 1.4MWh (megawatt hour) battery storage.

When will Pekat solar start operation?

The project awarded to Pekat Solar Sdn Bhd, will start in the fourth quarter of 2024, with commercial operation date by Dec 31, 2025. Pekat Group's share price was up 0.53 per cent to 94 sen, giving it a market capitalisation of RM606.3 million.
