High-Pressure Sales TacticsOne common complaint against subpar solar companies involves the use of high-pressure sales tactics,forcing customers to make hasty decisions. These tactics may include persistent calls,scare tactics,door-to-door visits,or making unfounded claims about solar benefits.

Are 'free solar panels' a scam?
