This means you may be able to bring your claimagainst your financial provider even if the company which sold you the solar panels has closed down. How much can I claim?

Can I recover money if my solar panels are faulty?

Every case is different, however, you may be able to recover up to 100% of your money as well as any other losses (for example, if the solar panels are faulty and not performing as well as promised). How do I make a claim for mis-sold solar panels?
