Standardised contracts include: Power Purchase Agreement, Implementation Agreement, O&M Agreement, Supply Agreement, Installation Agreement and Finance Facility Term Sheet. These are complemented by the Implementation Guidelines. Open Solar Contracts review phase is now over.

This solar PPA template document was developed by a group of solar developers, law firms, and other interested parties in the solar energy space. It represents a consensus around one possible approach to solar finance, with a particular emphasis on access to the broader capital markets.

What happens after the owner approves a solar PV (photovoltaic) system?

After the Owner approves the design of the solar PV (Photovoltaic) system,the Owner shall provide a Notice to Proceed to the Developer, at which time the Developer shall proceed with the construction of the Project. The Owner should own and maintain the Metering System with performance measurements.
