Do solar panels comply with building regulations?

These regulations may vary depending on the size and type of the installation. It's advisable to work with accredited installers who are familiar with these requirements.

Do solar panels need planning permission?

It is true that the majority of solar PV installations will be classed as a PD. However, there are instances where you will need to seek planning permission from your local authority. How many complaints are there about solar panels?

Can a solar panel be installed on a road?
