Who is included in the BP Solar Settlement?

The Settlement includes anyone in the United Stateswho: (1) purchased certain BP solar panels for installation on a property, or (2) currently owns a property on which these panels are installed and, in either case, who still owns some or all of the BP solar panels.

Are BP Solar panels eligible for a class action settlement?

If you have BP solar panels you may be entitled to replacement of the solar panels and/or a new inverter from a class action settlement. Important Updates: A new model number, BP365TS, has been added to the list of eligible Class Panels. Please see the Long Form Notice for further details.

Are BP Solar & Home Depot liable for a class action lawsuit?

Please see the Order for further details. A Settlement has been reached in a class action lawsuit against BP Solar and Home Depot involving solar panels manufactured between 1999 and 2007 with an S-type junction box ("Class Panels"). You may be entitled to benefits from a \$45.33 million common fund.

What happens if you sell solar panels to a company?

Often companies involved in selling solar panels to consumers don't treat their customers properly. Sometimes they damage people's roofs while they're installing the panels. Sometimes they sell the entire residential solar system to a company you've never heard of - and that company starts abusing the consumer.

Do you have a warranty on solar panels?

Some unscrupulous companies decide to just quit maintaining the solar system, letting it stop working or stop producing as much power as you were expecting. You may have a warrantyor a contract requiring them to maintain your residential solar panels in working order. Often, consumers have warranty rights even though they don't know it.

How can solar power companies protect you from fraud?

Every state has laws against fraud, and most states have consumer protection laws that prevent this kind of abuse. We can use those laws to recover your damages. Sometimes solar power companies try to collect debts that aren't owed, or they use abusive practices like harassing calls or charging baseless late fees.
